Prices

All lessons shall be paid monthly. Rates are shown below.

Policies

New Students

All new students are subject to a one-month probationary period. Students who fail to show a proper level of effort and a good attitude may, at the instructor's discretion, be dismissed from the trumpet studio.

Prorating for New Students

A new student beginning his or her lessons in mid-month may pay a prorated amount for the first month.

Lesson Payment and Scheduling

Monthly lessons shall be paid in advance at the first lesson of each month. Payment is for the entire month, and shall remain the same, regardless of whether that month contains three, four or five scheduled lessons. Each calendar year will include 48 scheduled lessons (averaging four per month), with two weeks being scheduled off for the Christmas Holiday and two others, usually during the spring/summer months.

Student Cancellation of Lessons

The student shall inform the instructor of lesson cancellation no later than 48 hours prior to the lesson time. Lessons cancelled within 48 hours of scheduled lesson time shall not be rescheduled or refunded, except in the case of illness or emergency.

Rescheduling of Appropriately Cancelled Lessons

In the case of lessons which are appropriately cancelled, the student will have an opportunity to make up the lesson, within the next two weeks following the cancelled lesson, in one of two ways:

1. to reschedule a lesson at Lazier's Harmony Music Studios to another date and/or time as the instructor's regular teaching schedule permits, or
2. to reschedule a lesson at the instructor's home as the instructor's personal and professional schedule permits.

Instructor Substitution and Cancellation of Lessons

Should the instructor be faced with a scheduling conflict, personal emergency or illness, the instructor shall reserve the right to do one of the following:

1. to arrange for a qualified substitute teacher to be present,
2. to reschedule the lesson at a mutually agreeable time and place, or
3. to issue a full refund for the lesson (25% subtracted from the lesson payment for the following month).

Weather Cancellation/Rescheduling

Cancellation, delay or early dismissal from the student's school does not affect private lessons. In the event of a weather cancellation, the instructor shall contact each student, and one of the following shall occur:

1. the lesson shall be rescheduled for later in the week, or
2. the student shall receive a full refund for the lesson (25% subtracted from the lesson payment for the following month).

Lesson Rescheduling for Holidays

Should a major holiday fall on a lesson day, lessons shall either be cancelled or moved to another day during that week. Surf to <http://www.drewfennell.com/PriStu/index.html> to view a calendar, schedule, and many other details.

Dismissal of Students

The instructor reserves the right to dismiss any student whose effort and/or attitude is consistently substandard, or who repeatedly cancels his lesson (whether within the 48 hour window or not). A dismissed student shall be refunded, in a prorated amount, for any subsequent lessons for which the student has prepaid.

Other Information

Lesson dates and times listed on the website (see the address below) are subject to change for various reasons, but may be considered firm two weeks prior – and usually no later than one month prior. In general, if you have questions, contact the instructor.
